1. The buyer shall agree to the price of gold determined by the Bank and transaction shall be executed based on the price fixed by the Bank.
2. The buyer shall deposit margin amount of 10% of the tentative gold price (as per international market) or NPR 1,000,000.00 whichever is higher before striking the deal.
3. Gold once sold shall not be taken back by the Bank. Buyer shall collect the gold within 7 working days without fail from the deal date. If not, bank will hold the authority to levy penal charges.
4. Bank will not be liable for the weight and quality of gold once sold and accepted by the buyer.
5. Buyer shall agree for any commission/charge levied by the Bank for Gold transaction, which may change from time to time.
6. Buyer shall present sales report/use of gold purchased from the bank within 7 working days from the date of delivery.
8. Payment made vide cheque/IPS/RTGS drawn on elsewhere shall be subject to realization of such instruments; the bank shall not be liable for any change in price until the realization of such cheque. Delivery of Gold shall be done only after realization of such instruments.
9. Buyer shall abide by the operating guideline of Gold import and sale issued by Nepal Rastra Bank and its amendments thereto from time to time
